HB 412: AGREE OR DISAGREE, IT'S THE LAW

At the May 2014 conference, Traffic Safety Resource Prosecutor Molly Miller gave a synopsis of the changes that House Bill 412 will make to §63-11-30 as of October 1, 2014. The information can be seen on the S.T.O.R.M. website by typing "HB 412" into the "Search News by Keyword" bar.

You should pay strict attention to §63-11-30(1), as it has changed the order of and the format of charges. The real damage created by HB 412 is 1) in the structure of the sentencing penalties and 2) in the number of loop holes opened for defendants to have at their disposal.

S.T.O.R.M. attempted many different avenues to have this bill rewritten, killed in committee, or defeated by vote. We were unsuccessful in our endeavors to prevent the passage of this bill, so it will be the law of the land.

Now What?

Our job as LEOs is still the same. We are to enforce the laws as written and do that to the best of our ability. We must not allow the sentencing penalties, which many believe impotent, to discourage us from doing our part. Our part in the fight against impaired driving is to detect, arrest, and present a case, clearly and convincingly to the Trier of fact. After that, it is out of our hands! If we have done our utmost, then we can lay our heads down and sleep with a clear conscience, no matter what hour that may be.

MADD's Campaign to Eliminate Drunk Driving focuses on three important steps we all can take today to stop drunk driving tomorrow:

- Support our heroes. Support high-visibility law enforcement to apprehend impaired drivers and discourage others from driving under the influence.
- Sober to start. Require ignition interlock devices or in-car breathalyzers for all DUI drivers to ensure they are sober before they drive.
- Secure the future. Support the development of technology that will automatically determine whether the driver's BAC is above the limit and cause the vehicle to become inoperable the driver is over the limit.

In 2012, 10,322 people were killed and approximately 335,000 were injured by an impaired driver. Every 53 minutes on average, someone is killed in a drunk driving crash. Every 90 seconds, someone is injured because of this preventable crime.

Labor Day Crackdown • August 15-September 1

NO EXCUSES. DRIVE SOBER OR GET PULLED OVER.

S.T.O.R.M. is teaming up with Mississippi's law enforcement agencies to put an end to the tragedies caused by drunk driving. Join us in this year's *Drive Sober or Get Pulled Over* high-visibility enforcement campaign, which will run from mid-August through the Labor Day holiday (August 15 through September 1), targeting a particularly dangerous time for encountering drunk drivers.

- Drunk driving kills more than 10,000 people every year.
- On average in 2012, one person was killed every 51 minutes in an alcohol-impaired driving crash.
- Holiday weekends bring a surge in drunk driving. Of all traffic fatalities over the 2012 Labor Day weekend (6 p.m. Friday to 5:59 a.m. Tuesday), 38 percent involved drunk drivers.
- During the Labor Day weekend in 2012, there were 147 people killed nationwide in crashes involving drivers or motorcyclists whose blood alcohol concentrations (BAC) registered at .08 grams per deciliter (g/dL) or higher.
